



Our Charter

Article 1 : The restaurant owner guarantees the quality of a personalized and warm welcome.

Article 2 : All the submitted dishes are made in the establishment.

Article 3 : The restaurant owner is committed to promoting the quality of the products used (whether they are certified or are in season) He/She must identify them precisely through the WD application in order to offer that visibility to consumers

Article 4 : Each restaurant owner is committed to promoting regional and local food used in his/her establishment through the application. The restaurant owner and his / her staff must be able to inform the customers about the origin of the products

Article 5 : The restaurant owners who have special conditions (a mountain restaurant, an insular restaurant, etc) where products delivery requires a specific means of transport, are committed to using, throughout the year, at least 40% of fresh food. With regard to the other restaurants, without any specific constraint, the restaurant owners are committed to using more than 60% of fresh food. If the restaurant owner runs out of some fresh food, he/she is committed to inform his/her customers as soon as they arrive.

Article 6 : The restaurant owner must be a professional or a passionate autodidact - skills that will enable him/her to design consistent meals.

Article 7 : In the aim of being fully credible, the restaurant owner will be able to inform through the application if his/her dishes contain allergens, if they are gluten-free, lactose-free, organic, vegan, etc. The more the restaurant owner will specify the specific conditions of his/her dishes, the more he/she will be referenced in the consumer's specific searches.

Article 8 : The restaurant owner is committed to respecting the concordance between his/her meal and his/her pictures. World Dishes is to be granted the right to exploit those pictures for commercial purpose



Article 9 : The restaurant owner is committed to respecting and applying the regulation regarding the hygiene of the premises, of the devices, of the staff and of the foodstuffs in accordance with the Decision of 9 May 1995.

Article 10 : The restaurant owner is committed to advising his/her customer the use of the mobile application.

Article 11 : WD is committed to adding, within 8 business days, each ingredient which is lacking in its glossary. To that end, the restaurant owner must anticipate the on-line release of a new dish.

Article 12 : WD reserves the right to exclude the restaurant owner in case this one does not respect the articles of the Charter. Each establishment will be controlled through the mobile application while respecting the need for transparency.

Article 13 : This is a one-year commitment to the WD label.

With regard to your dishes' pictures, we will announce to the consumers that they are not stipulated in a contract.

First, because of the complexity of an identical reproduction, and then because of the will of the Chief to change the facing at any time.

Dishes' picture is a way to evaluate amounts, to quickly see its content and to tantalize the WD user.

We shall strive to communicate, in order to clearly distinguish your dishes quantitative values, that rely on a manual preparation and the other issues of food chain
